*Reference forms must be submitted directly to The FPA of Wisconsin by the person submitting the reference on behalf of the applicant.*

Scholarship determinations are at the sole discretion of the FPA of Wisconsin’s Career Development Committee with approval of the Board of Directors. All scholarship decisions are final. Scholarship funds will be disbursed directly to the winner. Winners will be notified by letter and awards will be presented at a meeting of the FPA of Wisconsin.
